NTU IT Advisory Board Meeting Minutes for October 6, 2021

## Roll Call:

Present: Dr. Gil Gonzales, Norbert Nez, Laverne Moore, Jim Stewart, Dr. Casmir Agbaraji, Sumathi Ragavanantham, Tsosie Schneider

- I. Call to Order Meeting called to order at 2:08PM by Dr. Agbaraji.
- II. Roll Call Attendance taken by Dr. Agbaraji
- III. Approval of Agenda Lavern Moore motioned to approve the agenda; seconded by Dr. Gonzales

## IV. IT Advisory Board Membership

Dr. Agbaraji explained that there are currently 9 board members. By-laws would dictate how many members should be allowed. Lavern Moore suggests 3 members to start, then increase as time goes on. Dr. Agbaraji asks whether the board would like to amend the PEOS criteria 1, 2, and 3 and SLOs criteria 1-6 or would the board like to leave as is. Lavern Moore states that SLOs criteria 1-6 should stay the same. Board members agrees.

- VII. Accreditation Process for Computing Accreditation Commission (CAC) of ABET Dr. Agbaraji reviews all milestones in the ABET accreditation timeline.
- VIII. By-Laws
