
Certificate Program: Law Enforcement



Graph 2, Enrollment by Full- Time Equivalency:




Full Time Equivalency:

Graph 3, Enrollment by Gender:




The graph above represents the enrollment by male or female students that are enrolled in the Law Enforcement program.

Graph 5, showcases the student academic classification within the program.




Student academic classification refers to:

Graph 6, Student Status refers to the classification of enrolling students during a specified semester.

<u>Continuing students</u>: students who have continued their studies from Fall to Spring, or Spring to Fall semesters, without *stopping out*. (*stopping out* refers to a student who stopped attending the university and did not return during a fall or spring semester.

<u>First- Time in College</u>: students who has no prior post- secondary experience attending any institutions for the first time at the undergraduate level.

<u>Returning</u>: students who have stopped out for at least one semester (fall or spring semester) but have re- enrolled at Navajo Technical University to continue from seeking a degree or certificate.

Transfer: students who are entering the reporting institution for the first time but known have previously attend a post- secondary institution.
