WHAT IS A DUAL CREDIT PROGRAM?

“Dual credit program” is a program that allows high school students to enroll in college-level courses offered by a college or university. These courses may be academic or career technical but are not remedial nor developmental. Students can earn high school and college credits, which may meet high school graduation and college or university certificate or degree requirements. NTU has agreements with school districts allowing waiver of tuition/fees for participating high school students

Dual Credit is supported and sanctioned by New Mexico Legislation 6.30.7 NMAC (PED) and Arizona Revised Statutes (A.R.S.) § 15-342 (13), § 15-701.01 (F), § 15-1444 (B) (4), and § 15-1821.01.

ELIGIBLE COURSES

Remedial or developmental and physical education (P.E.) courses are not eligible for dual credit or concurrent enrollment. Students who are registering for an English or Math course will need to take the Accuplacer test to determine eligibility for that English/Math course. NTU also accepts ACT/SAT test results in place of the Accuplacer test.

DUAL CREDIT COURSE REQUIREMENTS

The course requirements for high school students enrolled in dual credit courses shall be equal to those of regular college students. Course requirement information shall include the course prerequisites, course content, grading policy, attendance requirements, course completion requirements, performance standards, and other related course information.

NTU collaborates with the school to identify courses that will be offered.

BENEFITS

- ✚ Earn credits for both high school and college in courses that are only offered at the college.
- ✚ Ease the transition from high school to college by giving students firsthand exposure to college-level work while gaining skills and building confidence.
- ✚ Discover or confirm what academic areas most interest you as possible career choices.
- ✚ All tuition and general fees are waived for students in participating schools (Dual Credit agreements are in place).

HOW TO APPLY

- ✚ Meet with your high school counselor.
- ✚ Permission from Parents and High School.
- ✚ Complete and submit the Dual Credit Student application and registration forms.
- ✚ Submit copies of Certificate of Indian Blood (CIB), if you are Native American.
- ✚ Submit copies of your high school transcripts.
- ✚ Provide ACT test scores or take the Accuplacer Placement Test where applicable.
