

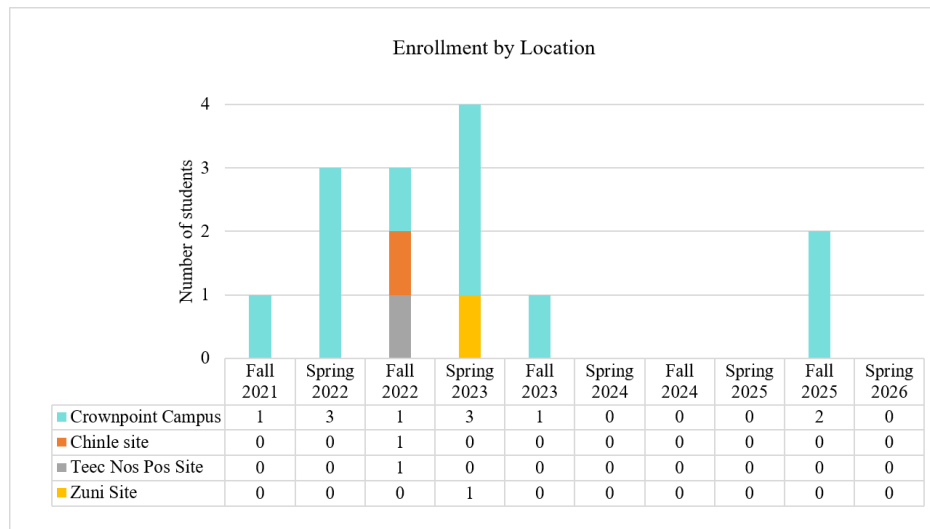
Certificate: Environmental Science & Natural Resources

The following student enrollment data is based on Census Day count here at Navajo Technical University (NTU). Census day count (or Freeze Day count) is collected on the third Friday after the semester begins. The data collected is from Fall 2021 to Spring 2026 semesters for this program. The Office of Institutional Data and Reporting works in collaboration with the Registrar and the Director of Enrollment to produce and certify the semester enrollment.

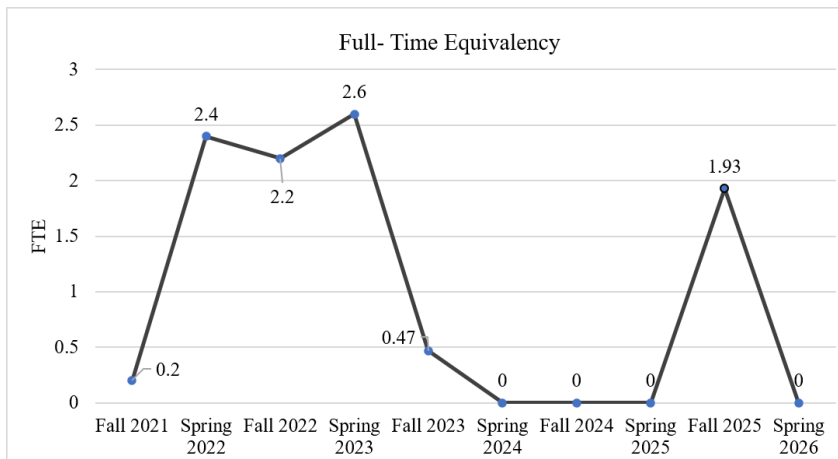

Graph 2, Enrollment by Full- Time Equivalency:

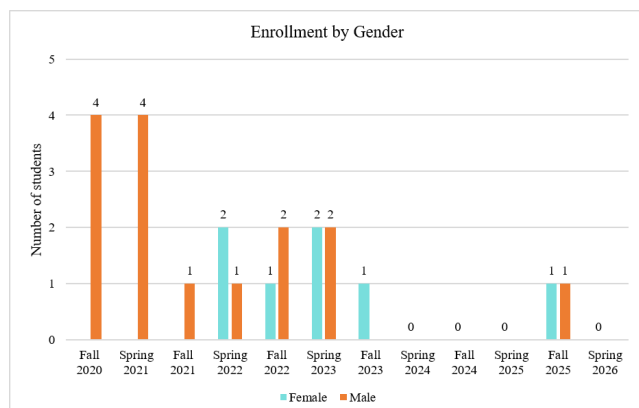

NTU utilizes New Mexico Higher Education definition and calculations to determine FTE:

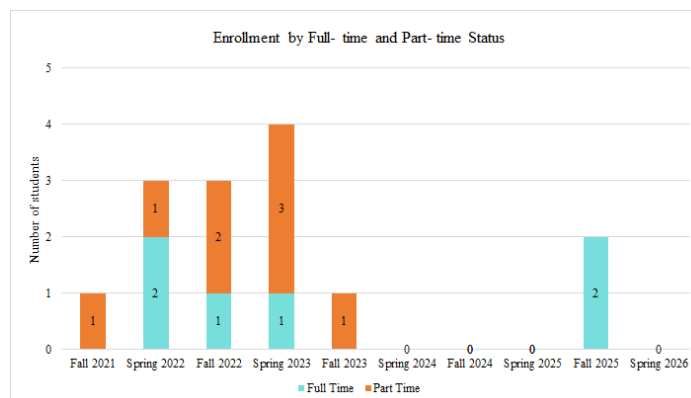
Undergraduates FTE =

Graph 3, Enrollment by Gender:



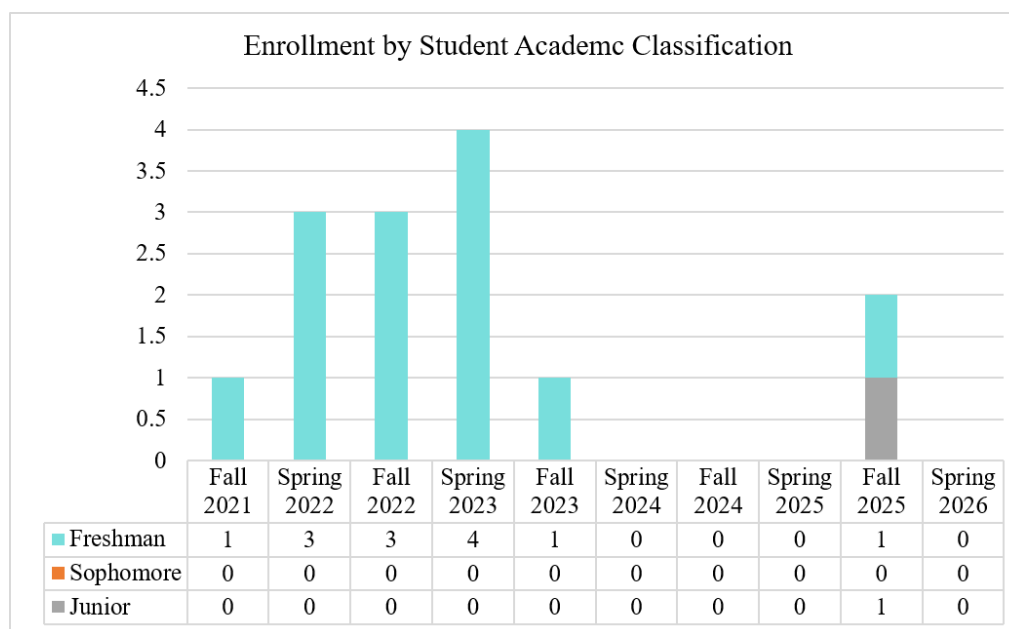
The graph above represents the enrollment by male or female students that are enrolled in the Environmental Science and Natural Resource program.

Graph 4, Enrollment by FT/ PT Status:



- Full-Time students are enrolled with 12 or more credit hours.
- Part- Time students are enrolled with 11 or less credit hours.

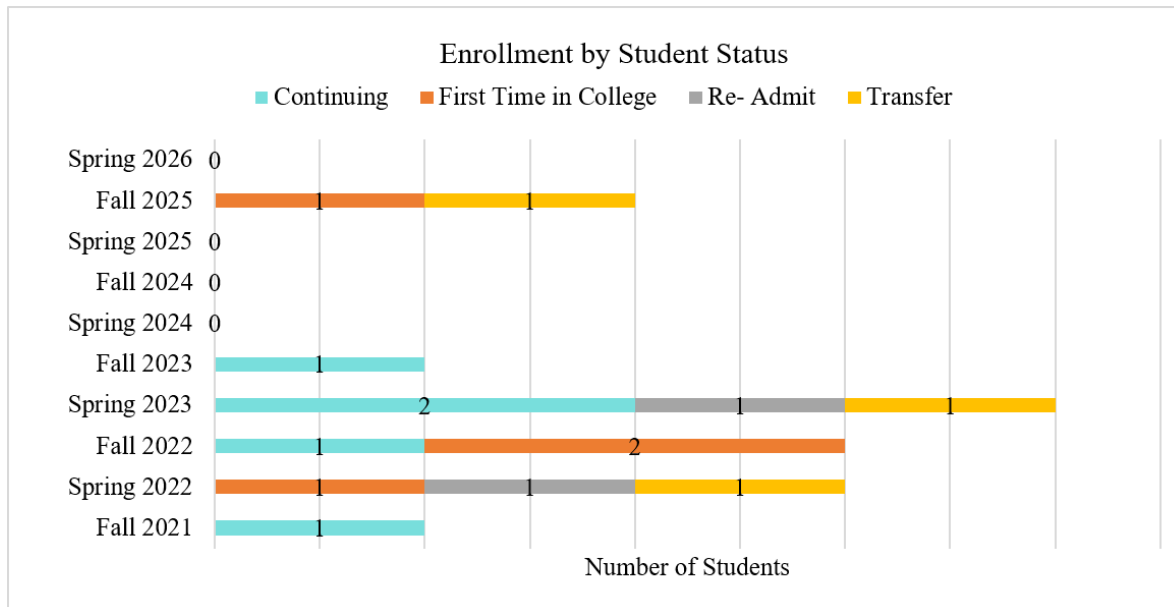
Graph 5 showcases the student academic classification within the program.



Student academic classification refers to:

- Freshman- A student who has completed 30 or less credit hours
- Sophomore- A student who has completed 31-59 credit hours
- Junior- A student who has completed 60-90 credit hours
- Senior- A student who has completed 91 or more credit hours

Graph 6, Student Status refers to the classification of enrolling students during a specified semester.



Continuing students: students who have continued their studies from Fall to Spring, or Spring to Fall semesters, without *stopping out*. (*stopping out* refers to a student who stopped attending the university and did not return during a fall or spring semester).

First- Time in College: students who has no prior post- secondary experience attending any institutions for the first time at the undergraduate level.

Returning: students who have stopped out for at least one semester (fall or spring semester) but have re-enrolled at Navajo Technical University to continue from seeking a degree or certificate.

Transfer: students who are entering the reporting institution for the first time but known have previously attend a post- secondary institution.
